**SECTION 4 – FIRST AID MEASURES**

Inhalation:	Remove to fresh air if effects occur. If not breathing, give artificial respiration. If breathing is difficult, oxygen should be administered by qualified personnel. Consult a physician or transport to a medical facility.
Eye Contact:	Immediately flush eyes with large quantities of water for at least 15 minutes. Maintain adequate ventilation and oxygenation of the patient. May cause respiratory sensitization or asthma-like symptoms. Bronchodilators, expectorants and antitussives may be of help. Treat bronchospasm with inhaled beta2 agonist and oral or parenteral corticosteroids. Respiratory symptoms, including pulmonary edema, may be delayed. Persons receiving significant exposure should be observed 24-48 hours for signs of respiratory distress. 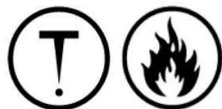
